#### **Terms & Conditions**

Effective Date: January 1, 2024

### 1. Introduction

Welcome to **Nikolas Marakakis Music** ("Website"). These terms and conditions govern your use of our services. By engaging our services, you agree to these terms. Please read them carefully. If you do not agree, please refrain from using our services.

### 2. Booking and Payment

- **2.1 Booking Confirmation** To secure the services of Nikolas Marakakis Music, a signed contract and a non-refundable booking fee (the amount in decided with the client) are required at the time of booking. For events outside of Chania, Crete, a 50% booking fee is required.
- **2.2 Payment Terms** Payments can be made via internet transfer or other mutually agreed methods. Full payment must be received at the date of the performance.

### 3. Services Provided

- **3.1 Performance** Nikolas Marakakis Music offers solo violin performances tailored to your event. The musician generally performs in 45-minute sets with 15-minute breaks per hour. Attire will be formal unless otherwise requested.
- **3.2 Special Requests** Clients may request specific songs outside of the provided repertoire. These requests should be made in advance and will be accommodated within reason.

### 4. Client Responsibilities

**4.1 Equipment and Setup** The client is responsible for providing any required equipment, outside the region of Chania, and ensuring it is in good

condition. For outdoor events, the client must provide adequate protection from weather elements.

**4.2 Timeline and Communication** The client must provide a detailed timeline of the event, which may be subject to changes. Open and timely communication between the client and musician is essential for a successful performance.

# 5. Cancellation and Rescheduling

- **5.1 Client Cancellation** If the client cancels more than 30 days before the event, no further fees will be due, but the non-refundable booking fee will be retained.
- **5.2 Rescheduling** If the event is rescheduled and the musician is available, all payments will be applied to the new date. If the musician is unavailable, the event will be treated as a cancellation.

### 6. Event Changes

Changes to the event, including time, location, or additional services, must be communicated and agreed upon in writing no later than 30 days before the event. Late changes may incur additional fees.

### 7. Travel and Additional Fees

- **7.1 Travel Fees** Travel within 30 km of Chania city center is included in the service fee. Additional travel fees will be charged for locations beyond this radius. The client is responsible for any parking, tolls, or valet fees at the event location.
- **7.2 Accommodation and Transport** For events outside of Crete, the musician will arrange all necessary accommodation and transport. These costs will be added to the final invoice.

## 8. Photography and Media

With the client's permission, Nikolas Marakakis Music may use photographs from the event for promotional purposes, including on our website and social media. No photographs will be resold without the client's consent.

## 9. Force Majeure

Nikolas Marakakis Music is not responsible for cancellations or delays caused by acts of God, government restrictions, or other unforeseen events beyond our control. In such cases, any payments made will be refunded, excluding the non-refundable booking fee.

# 10. Limitation of Liability

Our liability is limited to the total amount paid for our services. We will not be held responsible for any damages, injuries, or losses incurred during the event.

# 11. Governing Law

These terms and conditions are governed by the laws of Chania, Crete. Any disputes will be resolved in the courts of Chania.
